**Special Notes** –

1. Format – no more than 4 riders per group. You may choose and request an instructor from our volunteer instructor list, or we will assign an instructor. Only instructors pre-approved by the organizers are allowed. List will be posted at csdea.org under calendar.
2. Riding Day and Time requests are determined to a great deal by volunteer instructor availability. Note your preference, we will do our best to accommodate it.
3. Cancellation/Refunds –after closing date, no refund unless spot is filled from the waiting list.
4. Apparel – approved ASTM/SEI helmets. Safety vests, medical cards recommended.
5. Weather – we will ride in all types of weather unless lightening.
6. Stabling – No stabling on grounds.

**Directions to Trott Brook Farm**

If coming from Minneapolis area, go north on Hwy 169 through Anoka. It will turn into Hwy 47 (St. Francis Blvd) which you will take for about 6.5 miles north to 17902 St. Francis Blvd on your left. The driveway is directly across from the intersection of County Road 27 on your right, so watch for those signs. If you get to a stop sign at County Road 22 you've gone too far.

If coming from the west or east, you could take Highway 10 to Highway 47 and go north. Then follow directions above.
